Subject: Approval for changes in the requirement of Technical Feasibility Report (TFR) in line with the provisions contained in Electricity (Rights of Consumers) Amendment Rules, 2024 dated 22.02.2024.

Sir.

In reference to your letter No. 775/UPNED/PMSURYGHAR/2024-25 dated 17.05.2024 vide which it has been requested to issue necessary instructions to UPPCL regarding the changes in the requirement of Technical Feasibility Report (TFR) in line with the provisions contained in Electricity (Rights of Consumers) Amendment Rules, 2024 notified by the Ministry of Power, Govt. of India on 22.02.2024, the Commission approves the following amendments to the previously approved Procedure and Timeline vide letter No. UPERC/ Secy./(VCA)/2023-1769 dated 20.03.2023:

"i) For installation of roof top solar photo voltaic systems, the technical feasibility study shall be completed within a period of fifteen days and the outcome of the study shall be intimated to the applicant, failing which it shall be presumed that the proposal is technically feasible.

ii) The applications for roof top solar photo voltaic systems upto 10 kW capacity, complete in all respects shall be deemed to have been accepted without requiring technical feasibility study and any commensurate enhancement of the sanctioned load of the consumer, as may be required, shall be carried out by the distribution licensee."

All other provisions of the previously approved Procedure and Timeline shall remain the same.

This has been issued with the approval of the Hon'ble Commission.
